- Residential premises liability up to \$1M
- Deductibles starting at \$1,000
- Able to offer ACV, FRC, and RCV on a DP3 form
- Renovations coverage available for both cosmetic and structural renovations
- Schedules available
- Can offer exclusions for other structures, existing damage, roofs, animal liability, trampolines, swimming pools, and more
- No age limit
- Able to cover multiple occupancies (such as tenants and owners residing in same location) and vacation rentals

## **Target Classes**

- Monoline property and package (property & liability) available
- 1-4 family owner/tenant/seasonally occupied homes and vacant homes (including manufactured homes)
- Stand alone other structures (pole barns, detached garages)
- Residential premises liability includes "partnerships, joint ventures, limited liability companies, and trusts"
